LOCAL LAW NO. 1 - 1987

A LOCAL LAW INCREASING THE SALARIES OF SOME ELECTED COUNTY OFFICERS OR COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

- Section 1. The base annual salary of the County Administrator shall be the sum of Thirty One Thousand Six Hundred Twenty-Six Dollars (\$31,626).
- Section 2. The base annual salary of the County Clerk shall be the sum of Twenty Four Thousand Four Hundred Thirty-Five Dollars (\$24,435).
- Section 3. The base annual salary of the County Treasurer shall be the sum of Twenty Four Thousand Four Hundred Thirty-Five Dollars (\$24,435).
- Section 4. The base annual salary of the District Attorney shall be the sum of Twenty Four Thousand Eight Hundred Ninety-Five Dollars (\$24,895).
- Section 5. The base annual salary of the County Auditor shall be the sum of Nineteen Thousand Six Hundred Seven Dollars (\$19,607).
- Section 6. The base annual salary of the Budget Officer and Purchasing Agent shall be the sum of Twenty One Thousand Six Hundred Forty-Five Dollars (\$21,645).
- Section 7. The base annual salary of the Director of Real Property Tax Service Agency shall be the sum of Twenty Seven Thousand Four Hundred Five Dollars (\$27,405).
- Section 8. The base annual salary of the County Attorney shall be the sum of Twenty Six Thousand Three Hundred Fifty-Five Dollars (\$26,355).
- Section 9. The base annual salary of the Commissioners of the Board of Elections shall be the sum of Twelve Thousand One Hundred Eighteen Dollars (\$12,118).
- Section 10. The base annual salary of the Manager of Data Processing shall be the sum of Twenty Eight Thousand Seventy-Four Dollars (\$28,074).
- Section 11. The base annual salary of the Commissioner of Social Services shall be the sum of Thrity-Seven Thousand Two Hundred Eleven Dollars (\$37,211).
- Section 12. The base annual salary of the Director of Veterans' Service Agency shall be the sum of Sixteen Thousand Five Hundred Twenty-Four Dollars (\$16,524).
- Section 13. The base annual salary of the Director of the Office of the Aging shall be the sum of Twenty Thousand Six Hundred Twenty-One Dollars (\$20,621).
- Section 14. The base annual salary of the Commissioners of Civil Service shall be the sum of One Thousand Nine Hundred Thirty-Seven Dollars (\$1,937).
- Section 15. The base annual salary of the Fire Coordinator shall be the sum of Four Thousand Five Hundred Sixty Dollars (\$4,560).
- Section 16. The base annual salary of the Sheriff shall be the sum of Twenty Six Thousand Seven Hundred Seventy-Six Dollars (\$26,776).
- Section 17. The base annual salary of the Superintendent of Highways shall be the sum of Thirty Seven Thousand Six Hundred Thirty Five Dollars (\$37,635).
- Section 18. The rate of compensation of the County Coroners shall be the sum of Fifty-Five Dollars and Thirty-Five Cents (\$55.35).
- Section 19. The Salary Schedule for the year 1987 shall include the annual increments and longevity increments as they apply to each officer and employee listed in Sections 1 through 17.
 - Section 20. This Local Law shall take effect forty-five days after its adoption.

LOCAL LAW NO. 2 - 1987

A LOCAL LAW PROVIDING FOR THE RELEASE OR RETURN OF INSURANCE FUNDS RECEIVED UPON AGREEMENT TO RESTORE PREMISES

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

Section 1. The Treasurer of the County of Herkimer and/or the Enforcing Officer of his Office is hereby authorized and empowered to claim against the proceeds of a policy of fire insurance insuring the interest of an owner and issued on real property within the County of Herkimer to the extent of any lien thereon, as defined in Section 22 (1)(c) of the General Municipal Law of the State of New York.

Section 2. The amount which the County of Herkimer would be entitled to claim under the provisions of Section 22 of the General Municipal Law of the State of New York and Section 331 of the Insurance Law of the State of New York shall be released, or if paid to the County, returned, provided that the insured agrees with the County of Herkimer in writing to restore the affected premises to the same or improved condition that it was in prior to the time that the lien of the County of Herkimer against the proceeds provided for in Section 22 of said General Municipal Law arose.

Section 3. The Chairman of this Legislature is hereby authorized to execute such agreements provided that the Treasurer of the County of Herkimer certifies to said Chairman that said restoration work has been completed, or that the insured has given a performance bond for the proper completion of said restoration work, or that the funds necessary to complete said restoration work are being held in escrow pending proper completion thereof.

Section 4. This Local Law shall take effect immediately.
