## RESOLUTION AMENDING RULES OF THE COUNTY LEGISLATURE OF THE COUNTY OF HERKIMER

#### Sponsored by: Committee on Administration/Veterans' Affairs

WHEREAS, the Rules of the Herkimer County Legislature [hereinafter "the Rules"] at Rule 10 set forth the requirements to amend the rules; and

WHEREAS, Rule 10 specifies that any amendment to Rule 2 requires a two thirds (2/3) vote of all members of the Legislature; and

WHEREAS, Rule 2 provides that at the organizational meeting, the "Legislature shall elect a chairman to serve for two years" and further that the Legislature shall also elect a Vice Chairman; and

WHEREAS, Rule 44 provides that immediately following organization of the Legislature, County Legislators of the two political parties which shall have polled the largest vote in the last general election for Governor, shall elect leaders of their respective parties for a two year term; now therefore upon due consideration and a two thirds vote of the members of this Legislature; now, therefore, be it

RESOLVED, that Rule 2 be amended to add a last clause which shall state as follows:

Notwithstanding the two year term of office set forth above, at any meeting after the organizational meeting, the members of the Herkimer County Legislature upon two thirds (2/3) vote of all members of the Legislature may remove the Chairman and/or the Vice Chairman upon a determination of unethical conduct, criminal activity, incompetence, misuse of public funds, failure to reside in the district to which they were elected or breach of trust. Upon majority vote of all of the members of the Herkimer County Legislature, a new Chairman and/or Vice Chairman shall then be elected to complete the remainder of the two year term of the previous Chairman and Vice Chairman.

and, be it further

RESOLVED, that Rule 44 be amended to add a last clause which shall state as follows:

Notwithstanding the two year term of office for the Majority and Minority Leaders set forth above, at any meeting after the organizational meeting, the County Legislators of one or both political parties may, upon two third (2/3) vote of all members of the membership of the respective political parties may remove the Majority Leader and/or the Minority Leader upon a determination of unethical conduct, criminal activity, incompetence, misuse of public funds, failure to reside in the district to which they were elected or breach of trust. Further, upon majority vote, the County Legislators of one or both political parties shall then elect a new Majority Leader and/or Minority Leader to complete the remainder of the two year term of the previous Majority Leader and/or Minority Leader.

RESOLVED, that said amendment shall take effect immediately; and, be it further

RESOLVED, that certified copies of this Resolution be forwarded to the Clerk of the Legislature, County Administrator, County Attorney and Personnel Office.
